





Training Service Agreement

(SkillsLearn and the Client are individually referred to as a "Party" and collectively as "Parties")

Now both parties mutually agree upon the following terms and Conditions

L. Purpose:

The purpose of this collaboration is to provide training services to college students to support the vision of Party B through Party A's expertise in conducting skills development training programs at clients' premises starting from 19th August 2024.

2. Scope of the Work

- Party A offers Training services by conducting learning workshops for all the graduate students
 of the college to Party B according to the terms and conditions mentioned.
- SLA Training Services Involves:
- Computer software Technical Skills, Accounting and HR additional Courses, Strategic management, Project Management, and Client/customer relationship management workshops.
- · Soft skills- More than 25 soft skills to improve communications and leadership skills
- Preparation to Employment P2E program: Consists of 32 hr of Program for any stream of Students who are in the last 4 semesters of the Graduation/ Engineering/ Diploma.

a. Responsibilities of Party B during this contract period

- The college assigns a program coordinator to enable smooth coordination between SkillsLearn and the student community
- Organizing and communicating the workshop timetable to Students categorically for all semester students
- Sharing the student details with SLA for training purposes
- Fee collection support and administration support to SLA
- Sharing the required classroom and computer lab for training purposes on a specific time slot or duration.







b. Responsibilities of Party A during this contract period:

- 6. The minimum fee is decided based on the Operational Cost Incurred to offer each training program for the Students of the Institute(College) from the Service Provider, Every framing program fee will change according to the duration and the content.
- 7. Commercials: As per the mutual understanding, Annexure 1 describes the workshop content and the service charges to Party B. Invoices will be billed in the name of the Party B address mentioned above with the actual service charges and the standard tax applicable as per the Govt. 
